Reconnection Charges Prior to reconnecting a utility service disconnected following a delinquency, the customer shall pay to the City the entire balance due and owing to the City at the time of reconnection. The customer shall also pay a reconnection charge of \$25.00 for reconnection of electric &/or water. NO UTILITIES DISCONNECTED FOR THIS REASON WILL BE RE-CONNECTED ON SATURDAYS, SUNDAYS, HOLIDAYS OR AFTER NORMAL WORKING HOURS.
